

OFFICIAL RULES

FOOD LION/CLOROX GO GREEN, WIN GREEN WEEKLY SWEEPSTAKES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THESE SWEEPSTAKES. PURCHASING ANYTHING WILL NOT IMPROVE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY:** These sweepstakes are open to permanent legal residents of DE, FL, GA, KY, MD, NC, SC, PA, TN, VA, and WV who are 21 years of age or older as of September 2, 2009. Eligible participants who receive the Food Lion Shoppers' Companion e-newsletter (the 'e-newsletter') may enter into the Food Lion/Clorox Go Green, win Green Weekly Sweepstakes by opening the e-newsletter and clicking on the entry check box next to the weekly sweepstakes logo. Customers can sign up for the e-newsletter by visiting www.foodlion.com, clicking on the My Food Lion button, and following the sign-up instructions. Participants can subscribe to the Shoppers' Companion eNewsletter and enter the sweepstakes under only one email address. Once an email address has been submitted on the subscription form, that email address cannot be used by any other person for this sweepstakes.
